A Vehicle crossing permit was issued for the above mentioned property today.


As per Chapter 26, "Control of Vehicle Crossings" of the Far North District Council By-Law; a permit for the construction, repair, reconstruction or relocation of a vehicle crossing shall be valid for six months, during which time the work shall have been completed to the satisfaction of the Chief Executive. If construction, repair, reconstruction, or relocation of a vehicle crossing is not completed within six months of the date of issue of the permit, the permit shall be deemed to have expired and the permit holder shall be required to apply for a fresh permit and pay another fee before construction, repair, reconstruction or relocation can commence or be continued.

Approval to Construct a Vehicle Crossing

APPROVAL No: VX-2019-522

This approval to construct a Vehicle Crossing is given under clause 2603.1 of the Control of Vehicle Crossings bylaw of the Far North District Council.

Approval is given to **Goeffrey Keith England and Jeanette Milly England** for the construction of a vehicle crossing from **25 Taumatawiwi Street, Opononi 0473** to the property known as in the Legal Description **LOT 29 DP 61764**

The approval is given subject to the construction complying with Council's Engineering Standards for Vehicle Crossings and the following conditions:-

Prior to any excavation starting, the applicant must obtain a corridor access permit (car) and submit a traffic management plan for approval to Alan Wheatley (alan.wheatley@fndc.govt.nz or 021 533269).

The Maximum grade for the 5m of any non public access immediately abutting a carriageway or back of footpath shall not exceed 1 in 8

All non public accesses (rural / urban) shall be surfaced with permanent impermeable surfacing for at least the first 5m from the road carriageway or up to the road boundary, whichever is less, to prevent debris being carried onto the roads.
