Jane read out a letter from Genesis advising that they are putting a smart metre on the hall gas supply.

5 GENERAL BUSINESS

The following general business was discussed:

- Bug spray of units - This was last completed in June 2022. Further quote to be obtained by Jane from Green Agenda for the roof treatments.
- Wayne Fellingham resignation from committee has been regrettably accepted.
- Fence behind 21 Woodland drive which backs onto part of Unit 8, all of unit 9 and part of unit 10. Neighbour at 21 Woodland as contacted Colliers asking if something could be done about the items up against the fence on their side and provided quote for \$4640 incl GST. Quote needs to include removal of all soil/clay offsite also. Jane to see if the neighbouring property on Woodland drive that backs onto unit 10 might want to replace that section at the same time. It was agreed to proceed but village residents need to have 3 weeks to clear their side of the fence. Neighbour needs to clear his side of his fence also.
- Insurance renewal - Jane gave an indicative quote on the new premium but said this would change if the sum insured goes up. Committee agreed to leave the sum insured as is.
- Exterior repaint quote has come back at \$361,000 + GST.
- The vote as discussed at the EGM will not be sent out to owners as committee have decided, this is to remain following the Unit Titles Act. Jane is to catch up with Alan and Lesley when they return from holiday (2nd October).
- Plan for garden bin area - Brian moved to defer this to the New Year.
- Next Committee Meeting - 24th October 2023.
