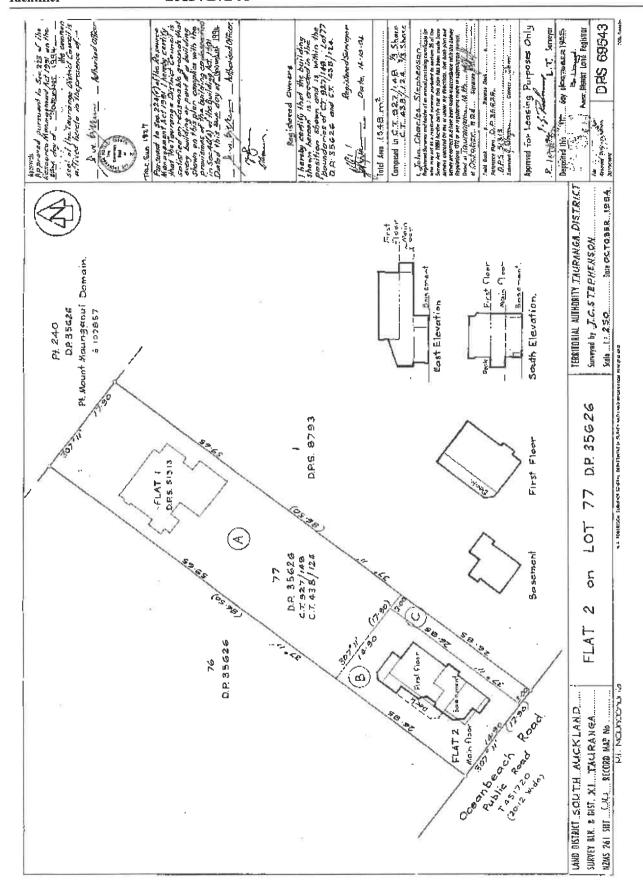

SCHEDULE B (Special Coverants for Leaguheld Experes)

31. IT IS HEREBY COVENANTED AND AGREED BY AND DETWEEN THE LESSUR AND THE LESSEE AS FOLLOWS.

- (c) the proceeds of such sale shall be paid to the Lessors who shall be entitled to deduct thereform all moneys owing by the Lessors and also all expenses and easts howsoever incurred by the Lessors in connection with the arranging of such sale and the completion thereof, and any balance of such proceeds shall be point to the Lessors;
