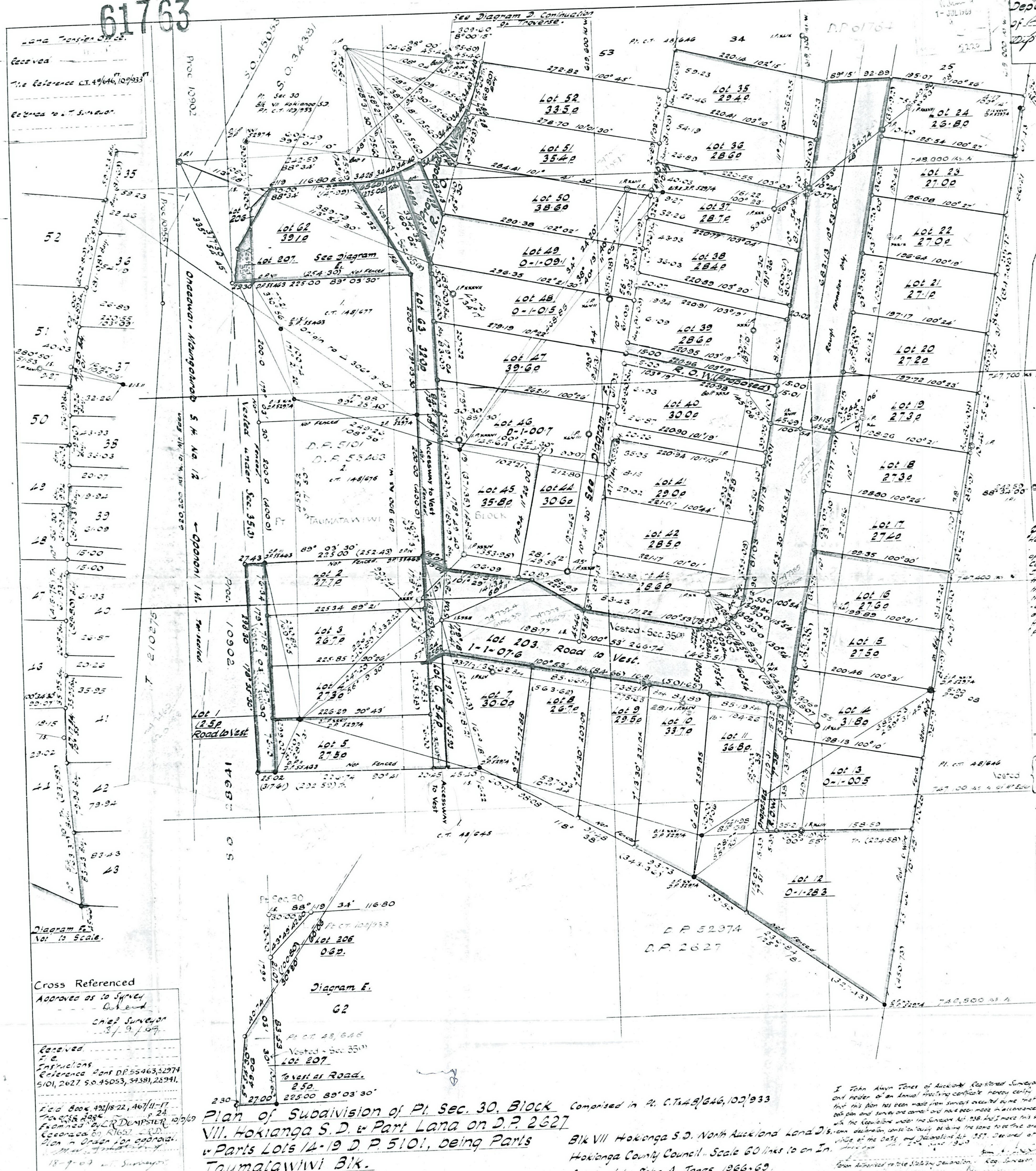


Diagram A Not to Scale.

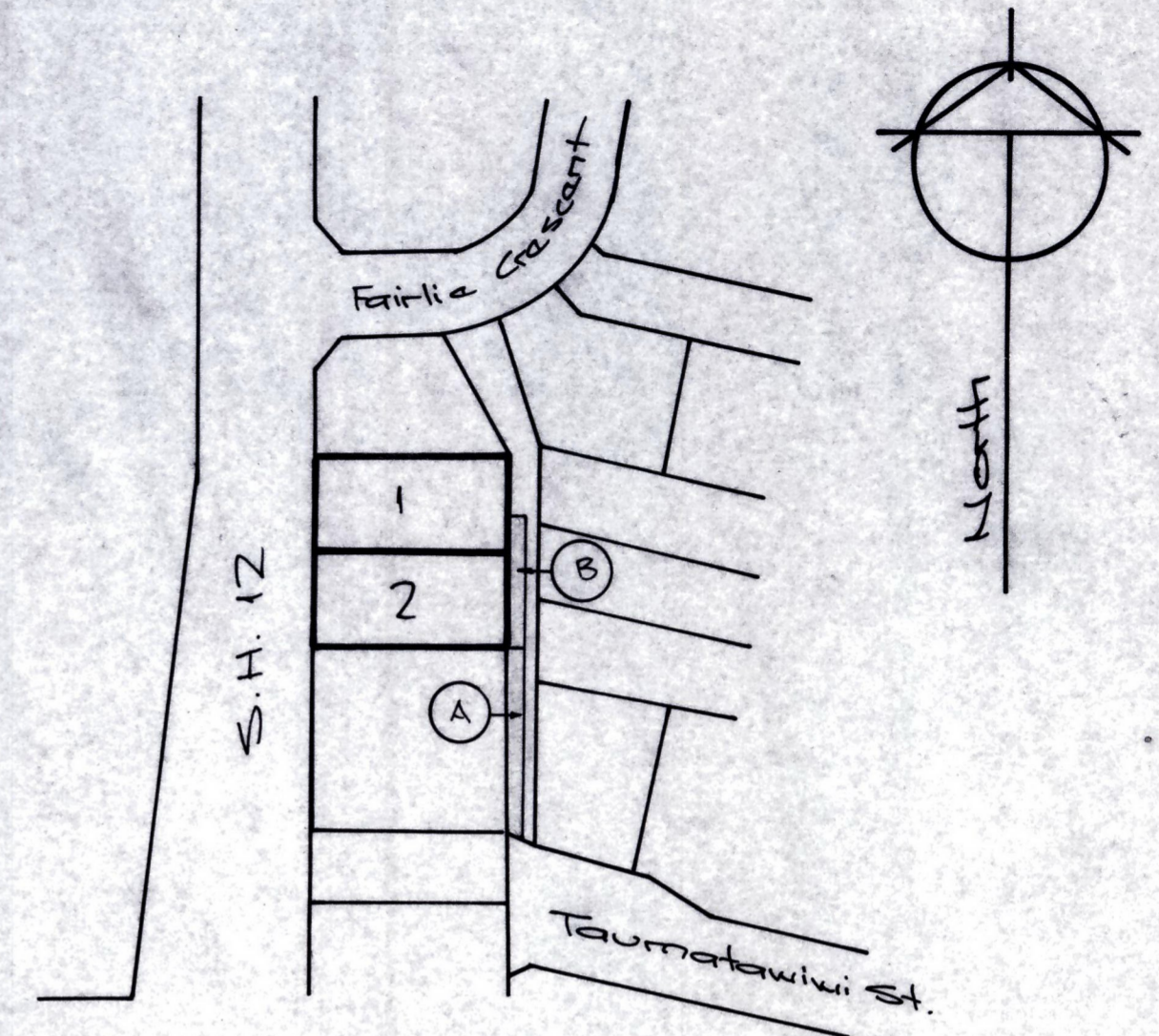

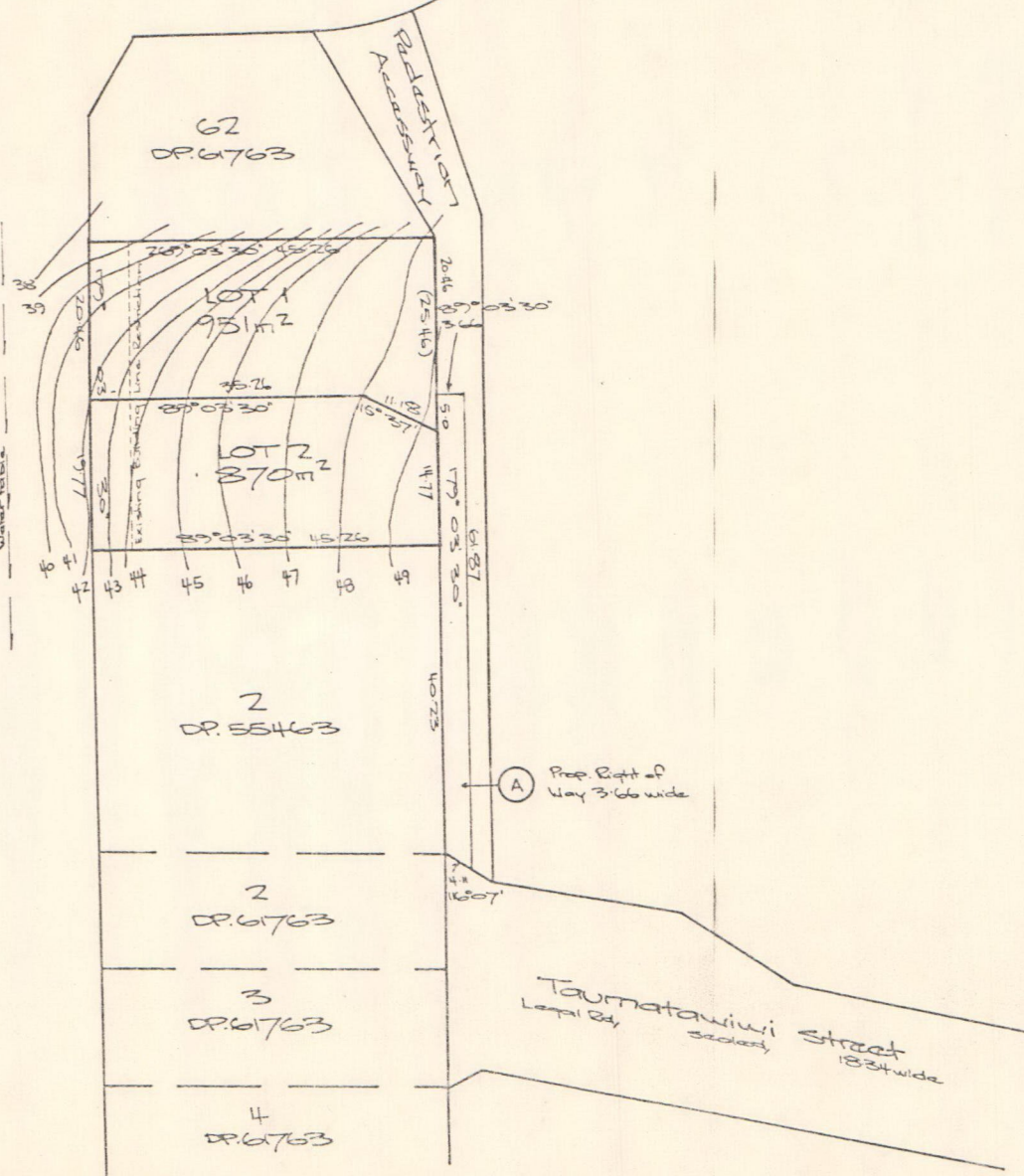

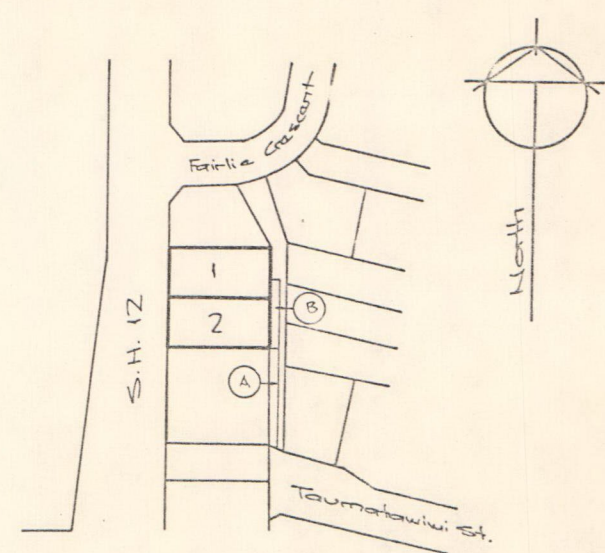
